<u>COMPLAINT</u>

Plaintiffs Avail Professional Services, LLC (Avail), and Chris Dussold (Dussold) (collectively, "<u>Plaintiffs</u>"), file this Complaint against Defendants Chey Lindsey Garrigan (Garrigan), and the Alabama Cannabis Industry Association (ACIA, or Association) (collectively, "<u>Defendants</u>"), and states as follows:

I. PARTIES, JURISDICTION, AND VENUE

1. Chris Dussold is a resident of Illinois. Through Avail, Dussold is a member of the Alabama Medical Cannabis Association (AMCA), conducting business in Montgomery and throughout Alabama.

2. Avail is a Missouri limited liability company conducting business in Alabama, providing finance and accounting services to members of the medical cannabis industry in Alabama.

3. Chey Lindsey Garrigan is an adult resident of Alabama who represents herself as an advocate for the legalization of cannabis and regularly conducts business in Montgomery on

behalf of the Association, lobbying legislators and meeting with the Governor and the Alabama Attorney General on issues facing the cannabis industry in Alabama.

4. The Association is a domestic nonprofit (501(c)(6) corporation with its principal office at 7907 Parkway Drive, Leeds, Alabama 35094. The Association, through Garrigan, regularly conducts business in Montgomery County, promoting the legalization of cannabis.

5. Jurisdiction is proper in this Court pursuant to Ala. Code § 12-11-30, and venue is proper in this Court pursuant to § 6-3-7.

II. FACTUAL BACKGROUND

6. The selection and awarding of licenses related to the newly minted medical cannabis industry has been fraught with growing pains, including various lawsuits and restraining orders sought by those entities seeking to rectify issues related to the award process.

7. The delays caused by the conduct of the Commission and its staff were widely known and publicized within Alabama. The issues raised by the various court actions were certain to delay any meaningful award of licenses and were known within the boundary of Alabama to mean a months-long backlog of license issuances, and the uncertainty of the industry's beginnings was of constant debate.

8. Garrigan and the Association, avid market participants by their own admission, were aware that the delay in the awarding process would not be resolved in any near foreseeable future, and certainly not by October 13, 2023 (the date of the anticipated conference made the subject of this suit.)

9. As of the filing of this matter, there are still license awards for integrated facilities and dispensaries (the backbone of the medical cannabis industry) yet to be awarded.

10. Despite this knowledge, Garrigan and the Association began to market an industry conference and celebration of the license awards. Garrigan and the Association solicited unsuspecting cannabis industry companies and individuals to participate and sponsor conference-related events.

11. Avail is a full-service financial advisory and accounting firm that provides clients with due diligence, strategy, accounting, and finance planning services. Dussold is its owner.

12. Avail and Dussold regularly participate in cannabis industry events around the United States.

13. Dussold was introduced to Garrigan and the Association through an individual he had done business with on several occasions, David Morrisey, who informed him that Garrigan and her Association were well-connected with the Alabama Medical Cannabis Commission (Commission).

14. Through a Zoom call initiated by Garrigan in the summer of 2023, Dussold and Garrigan discussed her connections to political figures, with Garrigan intimating her integral involvement with the creation of the Commission as well as her connection to the industry and the process of its creation in Alabama.

15. During this Zoom call, a discussion was also had about the alleged conference she was planning, seeking sponsors for the conference in exchange for certain levels of recognition before and during the conference.

16. Garrigan communicated with Dussold, culminating with Dussold agreeing to a sponsorship in the Conference to be held in Birmingham, Alabama on October 13, 2023.

Exhibit A, attached to this complaint and incorporated herein, is the agreement that was entered into by Dussold with Garrigan and her association on August 1, 2023.

17. As a result of the representations by Garrigan, Dussold entered into the sponsorship agreement and paid to Garrigan and her Association the sum of \$15,000.00 for said sponsorship.

18. Exhibit A outlines that the sponsorship level was to ensure certain marketing of Dussold and Avail was to take place in social media. Upon information and belief, Dussold and Avail's likeness and image were co-opted by Garrigan and the Association to lure other businesses familiar with Dussold and Avail, successfully obtaining sponsorships from these other vendors and businesses because of Dussold's and Avail's agreement to sponsorship. Several other vendors and businesses agreed to sponsorships after Avail had done so, leading the Association to profit more from Avail's sponsorship.

19. An invoice reflecting the date of August 1, 2023 was submitted to Dussold and Avail, attached hereto as Exhibit B.

20. On August 2, 2023, Garrigan sent Dussold wiring instructions for funds transfer of the conference sponsorship, attached hereto as Exhibit C to this complaint.

21. Said wire transfer was completed on August 5, 2023, and Garrigan and the Association received monies from Dussold and Avail. Attached hereto as Exhibit D is the transfer confirmation.

22. Upon information and belief, the marketing done for Dussold consisted of a single post on the social media outlet LinkedIn put out by the Association that received only limited viewing, the only registered reactions to the post came from Dussold and those connected to his organization.

23. Other marketing services were allegedly performed through a marketing firm that sent a communication to all the sponsors indicating that the firm was no longer employed by the Association, stating that the marketing services would then be continued by the Association. Exhibit E is an e-mail communication from Digital Venture Partners stating that as of September 30, just weeks before the scheduled date of the conference, they would no longer represent the Association and that all planning, marketing, and other conference logistics would be handled by the Association.

24. On October 4, 2023, notice was sent to several sponsors that the conference, which had originally been planned for October 13, 2023, barely eleven days before the scheduled event, the conference was being "postponed." Exhibit F is the e-mail from Chey Garrigan.

25. On October 22, 2023, a week beyond the originally contracted for event scheduled for October 13, 2023, Dussold was forced to send a communication to Garrigan for a return of the \$15,000.00 sponsorship fee. The time for performance had passed and Dussold and Avail were due the return of funds. Attached hereto as Exhibit G is the communication demanding the return of the fee.

26. As of this filing, neither Garrigan nor the Association has communicated with Dussold or Avail concerning any return of funds.

COUNT ONE

BREACH OF CONTRACT

27. Plaintiffs incorporate the preceding paragraphs as though fully set out herein.

28. There existed a valid contract for the sponsorship of an event during the Associations planned Conference to be held on October 13, 2023

29. Dussold was required to pay a total of \$15,000.00 as consideration for the marketing of Dussold and Avail both before and during the conference to be held on October 13, 2023. Dussold paid the sponsorship fee.

30. Defendants did not perform under the agreement, to wit: the conference was not held on the agreed date of October 13, 2023. Through communication defendants admitted to their breach; Exhibit F demonstrates that Garrigan nor the Association intended to return the money and were instead going to apply the money received toward an undetermined future conference.

31. Plaintiffs have demanded a return of the sponsorship money since the agreed to event did not take place.

32. Defendants have not returned the sponsorship money and have not communicated with the Plaintiffs in any manner regarding the funds return.

33. Defendants breached the agreement entered into and are still in breach of the agreement.

34. The Plaintiffs have been damaged. Dussold and Avail have not received a refund of the sponsorship fee of \$15,000.00 and have incurred losses for the past four months, with each day costing the Plaintiffs more as they cannot use the money being unlawfully withheld by the Defendants. Furthermore, the Plaintiffs have employed legal counsel to file suit to obtain the return of the money and expenses incurred because of the breach by the Defendants.

PRAYER FOR RELIEF

WHEREFORE, Plaintiffs asks that the Court enter judgment in its favor and against Defendants for compensatory damages, costs, interest, and its attorneys' fees, along with other, further, and different relief as this Court deems just and appropriate.

The inaugural Alabama Medical Cannabis Conference has been postponed.

On Wednesday the Alabama Cannabis Industry Association (ACIA) announced that their inaugural Alabama Medical Cannabis Conference has been postponed after Alabama Medical Cannabis Commission (AMCC) voted in September to stay the issuing of the cannabis licenses. Early indications are that the AMCC will extend their stay until their November meeting. "The inaugural 2023 Alabama Medical Cannabis Conference was planned to compliment the Alabama Medical Cannabis Commission, support the licensees, and celebrate the fact that in a few short months Alabamians with a legitimate medical need would finally be able to legally obtain lawfully grown Alabama cannabis to treat their conditions," the ACIA wrote in a statement. "We anticipated being able to register patients and provide CME credits to physicians."

"Unfortunately, the ongoing legal drama around the issuing of the license means that at this point in time, holding the conference on October 13, 2023, would be counterproductive," the ACIA continued. "We, at the Alabama Cannabis Industry Association, have consulted with our advisors, the presumptive licensees, and our legal counsel; and determined that the time is not right to celebrate the legalization of medical cannabis in Alabama as a timeline for issuing the license and getting the industry up and running would be speculative at best right now. The conference has had to be postponed."

In June, AMCC announced inaugural license awards; then days later stayed the issuing of the licenses. Litigation ensued and in August they did it over again – with some licensees losing their license – in August. That did nothing to satisfy the plaintiffs who have sued the AMCC. Lawsuits and litigants have only multiplied,

"The awardees are concerned that under the present circumstances anything they say and do will be used against them in pending and possible future litigation," the ACIA continued. There is also a strong possibility that the commission may have a new round of license awards and there is presently no clarity in what that will look like or even if the presumptive licensees will all still be awarded licenses if the Alabama Medical Cannabis Commission awards licenses for a **third** time."

"For these reasons and the fact that building the future medical cannabis grow and process facilities are at a standstill pending the actual issuing of the licenses, we felt we could not move forward with the conference at this time," the ACIA stated. "All attendees and exhibitors will receive credit toward future events."

It is expected that the AMCC expects to reissue the license awards at a meeting in November. The issue of who gets the limited number of licenses to grow, process, and dispense medical cannabis in the state of Alabama will likely ultimately be decided by a court and subject to appeal. It likely will not be decided before this year is over.

The ACIA will reschedule when they know more about when licenses will be issued and who the final licensees are.

"Expect more information on upcoming events in the coming months as we all look forward to the day that Alabamians with a diagnosed medical need can finally get the Alabama grown cannabis they need," the ACIA concluded.
